Air Associates and Alpha Pilot Academy's Alpha Pilot Squadron (referred to as the squadron) has been established and designed to provide privileges to squadron members with preferred prices for aircraft rental, along with other benefits.

**Membership Entitlement:**

As a member in good standing of the Alpha Pilot Squadron, the member has the right to rent the aircraft on our rental fleet for "block" pricing with no prepayment requirements. Members also shall receive:

- Proficiency training: Complimentary 1 hour dual full-motion simulator session every 6 months (Redbird MCX or FMX AATD with instructor)
- Solo use of Redbird for practice/IFR (club members only and hourly pricing applies)
- Insurance waiver fee is complimentary
- Future rollout of exciting Customer Loyalty Rewards Program
- More valuable benefits are being developed to roll out in the future for squadron members

**Rules & Requirements:**

1. All policies in the rental agreement apply to members of the squadron.
2. The named member is the only person allowed to operate the aircraft.
3. Member must have at a minimum, soloed an aircraft with Alpha Pilot Academy.
4. Alpha Pilot Academy does have the right to review and modify the aircraft pricing at any time to reflect changes in direct operating costs and expenses, but agrees to maintain approximately the same discount/dollar off that is established at the initial rate.
5. Alpha Pilot Academy has the right to refuse membership in the club to anyone.

**Cancellation:**

Membership is for a minimum of 6 months. The notice for cancellation must be in writing and prior to the 15<sup>th</sup> of the preceding month or member will be responsible for that month's dues. Should member cancel his/her membership, but has not been a member for the minimum 6 month time period, then the member must pay the remaining months at the time of cancellation, or continue their membership until the minimum time frame has been fulfilled.

**Fees:**

Monthly Due \$29.00 per month – member is required to pay the monthly due through a credit card on file with Air Associates/Alpha Pilot Academy.  
First Month's Dues: A pro-rated share of the first month's membership fee is due upon enrollment  
Payment for utilization: All fees associated with flight hours will be due at the time of service. Member will be required to submit a credit card guarantee of payment. Alpha Pilot Academy shall be authorized to apply the charges to the credit card.
